Lodging Discounts

Special lodging rates will be made available to expo participants. Information will be provided in a confirmation package upon acceptance by the event.

Deadline

All exhibitors should return the enclosed application, completed and signed. Deadline for submitting applications is **June 15, 2008. Space is limited.**

Submit

Mail two slides showing your booth and what you will be selling or displaying. Mark all slides/photos with your name. Please include an appropriately sized, self-addressed, stamped envelope for a prompt return of your slides and photos. (Booth fees and slides will be returned to you if you are not accepted). Include your website if you have one.

Festival Fees

A check must be included in your application made payable to the Town of Snowmass Village in the amount of \$250. Checks will be deposited upon receipt of application and refunded only if you are not accepted. A \$25 fee will be charged for all returned checks for cancellations. No refunds will be issued to an accepted vendor who cancels after June 15.

Taxes

Accepted applicants must complete a vendor license application and pay a vendor fee of \$15. The application will be given to you upon arrival at the Snowmass Wellness Experience. The total sales tax that will need to be collected on the sales is 9.9% (3.5% Town, 2.9% State, and 3.5% Country). You will receive a sales tax remittance form with your vendor license. This form will be used to remit 3.5% of the sales tax collected to the Town. If you have any questions, please contact Donna Garcia at (970) 923-3777.
